OPPD Cass County Station

OPPD recently began operation of two Cass County combustion turbines that added 320 megawatts of capacity to the utility's generation base. The turbines serve as peaking units, supplying electricity primarily during the hot summer days, when demand is at its highest.

Commonwealth Electric started working at the OPPD Cass County Station site in May of 2002. The project started with a Design Build contract to provide the electrical design and installation for OPPD's Service Building. This building included offices, warehouse space, and electrical equipment to support the Turbines.

Commonwealth was then selected to provide the underground ductbank system for the Turbines. This included the installation of approximately 65,000 feet of conduit, most of which was 5 inch.

Once the ductbank was finished, Commonwealth then started work on the above ground electric system for the two natural gas-fueled Simple-Cycle Combustion Turbines (160 MW each). This included installation and testing of the iso-phase bus duct, cable tray, conduit, cable, and instrumentation systems for the two turbines.

Henry Doorly Zoo - Kingdoms of the Night
