Phoenix Sky Harbor International Airport eGSE Infrastructure Improvements at Terminal 4

CECM Phoenix was recently awarded and work has commenced on the Ground Services Equipment Upgrades at the Phoenix Sky Harbor International Airport in Phoenix, Arizona.

The project scope of work will require improving the infrastructure and the installation of 28 new quick charging stations and removing the existing charging units, while providing cable and raceways throughout 5 different concourses. The project area is located at Terminal 4, encompassing South Concourses 2, 3, & 4 and North Concourses 3 & 4. This is to be utilized by both American and Southwest Airlines.

This job will entail critical and creative planning, scheduling and subcontractor direction as Commonwealth Electric Company of the Midwest will be the prime contractor for the City of Phoenix.



The project schedule is 175 days and the original contract amount is \$1,168,000.00. The Project Manager for Commonwealth Electric will be Caleb Graham and the Project Estimator is Jeff Campbell. Our Field Superintendent is Joe Amavisca.
